## Statute of Association Poznan University of Technology

1. Poznan University of Technology is a state-owned institution of higher education having legal personality.
2. The registered office of Poznan University of Technology is: pl. M. Skłodowskiej-Curie 5, 60-965 Poznan.
3. Poznan University of Technology, hereinafter referred to as PUT, was formed by virtue of the resolution number 701 of the Council of Ministers, dated 3 September 1955 regarding organizational changes in Higher Technical Education (Monitor Polski, number 83, item. 987). PUT continues the traditions of preceding Polish technical schools located in Poznan – State University School of Machine Design formed in 1919 as transformed into State University School of Machine Design and Electrical Engineering in 1928 as well as School of Engineering formed in 1945 and Evening School of Engineering formed in 1950.
4. PUT continues its activity by virtue of the Higher Education Law Act dated 20 July 2018 (Journal of Laws item. 1668), hereinafter referred to as the Act, other regulations regarding university schools and the Statute.
5. The scope of activity of PUT is determined, respectively, by article 11 of the Act.
6. PUT is administered, in the scope determined by the Act, by the Minister of Science and Higher Education.
7. The managing position, in regard to the activity of the entity and the representation thereof is held by the Rector. The Rector makes decisions, particularly those related to the property and administration of the school beyond the competence of ordinary school management.
8. Prorector for Research supervises the overall activity related to the realization of scientific research and foreign cooperation, apparatus administration and the matters of inventiveness at Poznan University of Technology. In this respect the Prorector is authorized to conclude agreements on behalf of Poznan University of Technology.
9. Poznan University of Technology has the following statistical number, according to REGON – a system of identification of entities: 000001608.
